# UNSW FITNESS & AQUATIC CENTRE TERMS AND CONDITIONS UPDATED: 31<sup>st</sup> JANUARY 2024

#### 1. GENERAL TERMS AND CONDITONS

- Clublinks on behalf of UNSW reserves the right to amend these Terms & Conditions from time to time as and when required.
- Terms & Conditions of participation in the UNSW Swim School Program delivered by Clublinks Management PTY LTD (Clublinks) on behalf of the University of New South Wales (UNSW) at the UNSW Fitness & Aquatic Centre.
- Clublinks on behalf of UNSW reserves the absolute discretion to terminate participation in any of the UNSW swim school programs at any time for any reason.

## 2. PARTIES TO CONTRACT

• The "Branch" means the organisation providing the service for which the Customer is paying being Clublinks Management Pty Ltd Trading as UNSW Fitness & Aquatic Centre. The "Customer" means you: the person or party signing this Contract.

## 3. ACCESS TO FACILITY & PROGRAMS

- Opening hours and access to facilities and programs may vary in line with public holidays and at times may vary due to operational circumstances.
- We endeavour to communicate promptly and swiftly should regular trading hours or programs change either by newsletter, poster displayed in the centre or written notification using the most up to date physical or email address you have given.
- Please ensure your contact details are up to date via your Online Client Portal.
- Usual Operating Hours are:
  - o 6am until 10pm Monday to Friday
  - o 7am until 7pm on Saturday and Sunday.
  - Public Holiday trading hours are usually 7am to 7pm but may vary depending on the holiday.
- Members on Thrive Memberships can access the Gym, Pool, Steam Room, and Group Fitness facilities.
- Members on Dive Memberships can access the Pool and Steam Room (Group Exercise Classes are not included)
- Access to services on a ten (10) Visit Pass is subjective to the pass purchased.
- Access to Stadium and Sport facilities is not permitted with membership, all Patrons are permitted to pay an additional fee to access these areas.

## 4. MEMBERSHIP FEE & PRICE INCREASES

- If you have joined on a 3 or 12 month membership term, then, after your minimum term has expired your membership may increase automatically from the next direct debit date and annually thereafter.
- We will notify you of your membership increase at least 28 days prior to any such increase either by newsletter, poster displayed in the centre or written notification using the most up to date physical or email address you have given.

### 5. COOLING OFF PERIOD

- There is 7 business day cooling off period for all membership types.
- The cooling-off period applies to new memberships only and does not apply to membership transfers or renewals.
- The cooling off period starts form the date the Agreement is entered into (the date the Agreement is signed) and ends at the close of the 7 business days later.



- Your membership can be cancelled during the cooling off period by visiting the UNSW Fitness & Aquatic Centre in person and completing the cancellation form available at reception.
- All monies paid will be refunded except for a reasonable administration fee which shall be payable by you if your membership card and/or other merchandise you received on joining are not returned within the seven (7) days of termination of your Agreement.

## 6. SUSPENSION OF MEMBERSHIP

- All Direct Debit memberships and 12 Month Upfront membership holders are eligible to suspend their membership for 8 weeks complimentary and an additional 4 weeks at \$2.50 per week per calendar year.
- Visit Passes and 3-month upfront membership holders are not permitted to suspend their membership.
- The minimum duration per suspension request cannot be no less than 7 days.
- Suspensions cannot under any circumstance be back dated and must be submitted at least 24 hours before the intended suspension start date.
- Suspension requests must be submitted via the members Online Client Portal. In person, over the phone or emails requesting a suspension are not permitted.
- Membership suspensions due to medical reasons should be accompanied by a medical
  certificated clearly stating the length of the suspension period as advised by the allied
  health professional which will allow the suspension period to extend beyond the 12-week
  maximum at no charge.
- Medical Suspension requests must be requested in person by visiting UNSW Fitness & Aquatic Centre reception.
- Cancelling during a suspension period is not permitted.
- Learn to Swim Enrolment Suspension Terms and Conditions differ to the General Terms and Conditions— See Learn to Swim Suspension Terms and Conditions for details.

## 7. DIRECT DEBIT MEMBERSHIPS

- All direct debit memberships and enrolments are ongoing, and payments continue
  past the agreed commitment period until a request to cancel is submitted with 28
  days' notice.
- Payments are scheduled for debit on a fortnightly cycle covering 2 weeks in advance.
- At the time of joining, Pro Rata is payable covering from the day of starting up until the day before the first direct debit cycle.
- Transaction fees for card payments apply as per below table:

Payment Method	Transaction Fee
Bank accounts	\$0.50 per transaction
Visa / Mastercard	\$0.43 + 1.65% of transaction amount
Visa / Mastercard (International)	\$0.43 + 2.75% of transaction amount
American Express	\$0.43 + 2.50% of transaction amount

• A rejection fee of \$10 applies for any missed direct debit payment.

# 8. CANCELLATIONS

- Should a member wish to cancel their membership within an agreed contract term period, the member will be required to pay a \$200 early exit fee.
- Members on upfront paid in advance memberships are not permitted to cancel nor request a refund.
- Upfront memberships are non-refundable or transferrable.



- Your membership can be cancelled by contacting UNSW Fitness & Aquatic Centre in person and completing the cancellation form available at reception.
- If early termination request is due to a medical condition and a medical certificate stating inability to exercise, the early exit fee may be waived.
- If you have moved 10KM+ from UNSW Fitness and Aquatics Centre, providing official
  documentation (utility bill, rental agreement or driver's license) that states the new
  address may also result in the early exit fee being waived.
- All fees are payable during the 28-day notice period and cancellations cannot be submitted during suspension periods.

#### 9. TRANSFER OF MEMBERSHIP

- You can transfer your membership to another person (transferee) within the minimum term of your agreement so long as the transferee:
  - Is not a current member.
  - o Has not been a member in the last 3 months
  - o Completes the new membership sign up process
  - Is eligible to take up your membership (for instance, you cannot transfer a concession membership to someone who would not qualify for that membership); and
  - Has not previously been banned from UNSW Fitness & Aquatic Centre or failed to pay membership fees.
- Both parties must be present in person at the time of transferring, and this must be done at UNSW Fitness & Aquatic Reception with a team member.
- A transfer fee of \$60 applies and should be paid before the transfer can be processed.
- Visit pass and paid upfront memberships cannot be transferred.
- The transfer is effective only after the transferee has completed the sign-up process.
- The transferee is subject to the same membership terms and conditions as the original membership.
- We do not allow transfers once you have completed your minimum term.

# 10. SQUAD MEMBERSHIPS & PROGRAM BREAKS

- Squad Memberships terms for cancelling and suspending are as per the general terms and conditions.
- Squad Program sessions break during Public Holiday periods and for a longer duration over the December and January Holidays – Dates are subject to management discretion and vary each year.
- Squad members can use the Pool facilities for general use outside squad session times part of their membership.
- We will notify you at least 7 days prior to these breaks with exact dates and times either by newsletter, poster displayed in the centre or written notification using the most up to date physical or email address you have given.
- Squad Members will continue to be charged during break periods which permits access to
  use the pool during this time.
- Squad Coaches may vary depending on availability.
- Squad members can choose to suspend their membership during break periods at their discretion in line with the General Suspension Terms and Conditions.



#### 11. FITNESS PASSPORT

- Fitness Passport members must complete a Pre-Exercise Questionnaire and registration form on their first visit.
- Fitness Passport members must sign in at Gym Reception with their Fitness Passport membership Card.
- Access will not be permitted for Fitness Passport members who do not have their Fitness Passport membership card.
- Fitness Passport Members must adhere to all Fitness Passport Terms and Conditions as well as UNSW FAC Terms and Conditions.

#### 12. CONDITIONS OF ENTRY

# 12.1 Facility Conditions of Entry

- UNSW Fitness and Aquatic Centre has a ZERO tolerance policy towards the physical or verbal abuse of patrons or staff. Offenders will be removed from the Centre.
- Cameras and mobile phones are not permitted in changing rooms.
- No pets or animals are permitted within the Centre except for Assistance animals (UNSW Management Approval Required)
- UNSW Fitness and Aquatic Centre accepts no responsibility for lost or stolen belongings.
   Patrons have free access to secure lockers and are encouraged to place any personal items in them for the duration of their visit.
- No external commercial food products are to be brought into the facility.
- UNSW Fitness and Aquatic Centre is a non-smoking venue (vapes included)
- Drugs, alcohol, and people under the influence are strictly prohibited.
- Patrons are not permitted to bring glass objects, or alcohol into the Centre. We reserve the right to search patrons' bag if any of these items are suspected to be in a patron possession.
- Anyone attempting to gain entry without paying or without authorisation may be prosecuted.
- Patrons must not record or broadcast anything from within the centre unless written permission has been provided by Centre Management.

## 12.2 Aquatic Conditions of Entry

- All patrons must adhere to the "Keep Watch at Public Pools Policy".
- Children ages 5 and under must always be within arm's reach of an adult.
- Children ages 6-10 require constant active supervision.
- Children ages 11-14 require regular supervision from an adult.
- Spectators are not permitted to enter any body of water until a casual visit is purchased.
   Anyone found to be using the facility without purchasing the proper entry will be asked to leave until they have purchased the correct facility access pass.
- Unacceptable/Inappropriate swimwear includes and is not limited to:
  - o Denim
  - Street Footwear
  - o Underwear
  - Street clothes,
  - Sport/ gym clothes
- Only recognised swimwear can be worn in the pool and steam room. Only recognised waterproof nappies are to be worn in the water for infants.
- Please always observe pool rules, including shower before entering pool or steam room
- UNSW Fitness and Aquatic Centre staff are only permitted to conduct learn to swim, private swimming lessons and squad coaching. Please always observe pool rules, including shower before entering pool or steam room

## 12.3 Fitness Centre Conditions of Entry

- All patrons using the fitness facilities must use a towel when working out.
- UNSW Fitness and Aquatic Centre reserves the right to refuse entry to anyone who does not



have a towel.

- Anyone attempting to gain entry without paying or without authorisation may be prosecuted.
- Children under the age of 15 cannot use the gym. Children aged 15 are permitted to use
  the gym under direct supervision from a parent/ Guardian. Children aged 16-17 Must have
  their membership signed by a parent / guardian. Failure to comply will result in
  termination of membership.
- UNSW
- Fitness and Aquatic Centre staff are only permitted to conduct tours of the facility.
- Only enclosed footwear and appropriate activewear is to be worn in the fitness facilities.
- Unacceptable/Inappropriate footwear include but is not limited to:
  - Flipflops
  - Slides
  - Ugg boots
  - Birkenstocks
  - Crocs

# 13. Stadium Conditions of Entry

- Appropriate Casual ticket purchases must be made at reception.
- Memberships do not include casual shooting for facility hire.
- Children under the age of 15 must be accompanied by a parent/ guardian.
- Patrons will be liable for any willful damage done to fixtures, fittings and equipment.
- Appropriate attire is to be worn when using the facility.
- Unacceptable/Inappropriate attire include and is not limited to;
  - No shirt
  - No shoes
  - Open toes shoes
  - o Jeans
  - o Dress shoes

# 14. ENTITLEMENT

Provision of services provided by the Branch may change and for the purposes of this Contract is based on "entitlement" to use and not on actual use. By signing this agreement, you are agreeing to be bound by the rules and conditions of the Branch. The Management at the UNSW Fitness & Aquatic Centre reserves the right to cancel the rights of any member not complying with the conditions of membership or rules of the Branch at any time.

## **15. PROVISION OF SERVICE**

Change of location or ownership or the name of the Branch does not absolve you of your responsibilities under the terms and conditions of this Contract.

## **16. ENTIRE AGREEMENT**

This Contract constitutes the entire agreement, understanding and arrangement (express and implied) between you, the Customer, UNSW Fitness & Aquatic Centre relating to the subject matter of this Contract and supersedes and cancels any previous agreement, understanding and arrangement relating thereto whether written or oral.

# 17. LIABILITY

- To the extent permitted by law, UNSW Fitness & Aquatic Centre shall not be liable or responsible to you for any direct, indirect, or consequential injury, loss or damage whatsoever and however arising.
- UNSW Fitness & Aquatic Centre is not responsible for lost or stolen items or damage to property or vehicles.
- Acknowledging this risk, you agree to use the Branch at your own risk.
